1. Your Agreement to these Terms

Summary: When you use Codana, you are agreeing to these terms and our Privacy Policy, and promising to safeguard your account. You agree that you are of legal age to accept these terms.

Acceptance of Terms

Codana, Inc., a Delaware corporation ("Codana") provides users with a hosted environment and community to code, build, share, and deploy software and web servers through our websites and apps (the "Service"). 1By using the Service, you are entering into a binding agreement with Codana, and you agree to comply with these Terms of Service ("Terms") and also agree to our Privacy Policy; if you do not agree, you must not use the Service. 2 1.1 Account Usage and Security

Codana may establish usage quotas and limits that govern your usage of the platform, including but not limited to computing resources, storage, and data transfer. 17You agree to follow these quotas and limits as they are defined by Codana. 18

3. Content on Codana

Summary: You affirm you own the rights to the content you post to Codana. You give us permission to host your content, make your content available to others, and to use it to improve our Service.
